Legal Services for Children's THEORY OF CHANGE



WHEN LSC provides quality legal advocacy and social work services for children & young people and actively involves them in decisions, THEN they access their legal rights, advance their goals, begin to heal from trauma, and thrive.

CRITICAL NEED

ALL CHILDREN & YOUNG PEOPLE DESERVE a safe and stable home with loving caregivers, access to legal immigration status, freedom from detention, and access to education. Additionally, children & young people deserve the opportunity to play a meaningful role in important decisions about their lives and are often not afforded this opportunity. Many children & young people experience abuse from adults, systemic oppression, and institutional abuse. To address these challenges, YOUTH-DIRECTED LEGAL AND SOCIAL WORK SERVICES are often required to exercise their rights. More resources are needed to support this work.

WHOM WE SERVE

CHILDREN & YOUNG PEOPLE WHO HAVE EXPERIENCED CRISIS OR TRAUMA and have needs that are not being met by the adults and/or systems responsible for their care, have low or no income, and are located in or connected to San Francisco or the greater SF Bay Area. We accept clients regardless of complex needs, delinquency or criminal history, or language translation needs.
